REPORTS from the FIRE CHIEF AND COMMAND

Fire -

Ambulance – The ambulance that was involved in a traffic accident has been totaled by the insurance company. The biggest problem is availability of vehicles. Even if we ordered a new one now we are looking at 18 months before we take possession. The

officers are evaluating options such as buying a used one, operating with only 2 ambulances or ordering another one and we will not receive it for 18 months. The one we have on order and paid for over a year ago still is not in production. The cost of a new ambulance is between \$385,000 and \$410,000.

We are operating with one paramedic position not filled so we have hired 2 part time paramedics and then a full time paramedic to cover all the shifts.

LLS – Financials were disbursed.
