REPORTS from the FIRE CHIEF AND COMMAND

Fire

- J. Schmandle has rendered his resignation. He is not unhappy with the district, just need to focus on family and his personal life.
- 2 new members are onboarding for part time positions.
- The officers are moving forward with the purchase of a new engine. The plan is to duplicate Engine 323 with a few minor adjustments. They were looking into lowering the hose bed by reducing the tank size but it would only move it 4 inches and removing the generator because so much of our equipment is now battery operated. They have contacted McQueen for a Pierce engine and we are looking at \$1,175,000.
- A town hall meeting was held in Millbrook to try and work out some concerns that those residents have regarding our presence at the Millbrook station. Kreinbrink had statistics showing that for 2024 the percent of calls for Millbrook was 1.57% and for 2025 it was 2.1%. In an effort to help out that part of our district things that are being worked on is:
 - Auto aid with Newark
 - CPR training for the residents
 - Offering homeowners to purchase an AED at a discounted cost
