REPORT OF THE FIRE CHIEF AND COMMAND

Fire

- The personnel cap is gone and the roster is 68 or 69 to allow call coverage because time is limited for most members. Effective August 1, 2011 the compensation is going to be adjusted because members that were showing up late are earning as much as those individuals that come and make the call or come and work at the station during the call. Those that do try to make the call and stay and work at the station will get as much as those those that make the call. If an individual comes, signs in and leaves then they will only get half the credit.
- Witek is working to get an auto-aid agreement in place with Newark so that we can provide paramedic service to Newark district (especially Millbrook Estates) and we would reimburse their ambulance fee from what we charge.
- Approximately 3500 gallons of water was in the Millbrook Fire Station basement when a ball valve broke and the pump kicked on and filled the basement. It will be turned into the insurance company.
- The garage doors at station #3 need to be repainted. The red paint is fading and peeling.
 \$7,700 is an estimate to soda blast, prime and repaint them white and Sherwin Williams will guarantee the paint. Wade suggested electrostatic and would like it investigated.
 DeBolt made a motion to get the garage doors redone and include the weather stripping not to exceed \$8,500.00 Brummel seconded the motion. All ayes, motion carried.

EMS

- Numbers were distributed.
- They had the first ambulance ordering committee meeting. The committee has looked at one demo and will review another then they will go to Cleveland to see final options.
- The ambulance that is 2 years old is very rough riding. They are looking to improve with an adjustment to the suspension.
