UNFINISHED BUSINESS

- Two bids for the boat were received. After opening and reviewing the bids. Fred Davis bought the
 boat and trailer "as is" for \$537.85. Brummel made a motion to accept the bid. DeBolt seconded
 the motion. All ayes, motion carried.
- Lease #1 Negotiations are in process. City of Plano buildings and grounds committee is meeting and new information could be available soon.
- Mortgages are all signed and we will own both stations in 7 years.
- The Plano TIF District no activity.
- Jordan and Schiradelly were at the meeting to present the bids for the new apparatus purchase. A lot of work (9 months) has gone into planning and designing the new equipment. The new rescue pumper will replace a rescue truck and engine into one piece of equipment. All companies were provided with an unnamed drawing and asked to bid. In a side by side comparison excluding price the Pierce excelled. Pierce was also the lowest price. Pierce offers 5.25% on the advance payment so we will give them a \$500,000 advance. It is the officers recommendation to sell 371, 329 & 372. Brummel made a motion to purchase the Pierce at a price not to exceed \$547,700. DeBolt seconded the motion. Roll call vote was taken:

NEW BUSINESS

Insurance policies are up for renewal and rebidding because the first time we used Corkill was 3 years ago. The company that the policies were with, no longer writes fire district insurance so they have found a new company with competitive prices. Continental Western will be the new carrier. An option to increase the blanket dishonesty policy to \$2,000,000 will cost an additional \$1,433 and changing the deductible to \$1,000 will save \$1,800. So both of these options will be put in place. DeBolt made a motion to accept these policies with the changes. Wade seconded. Roll call vote was taken:
