REPORTS from the FIRE CHIEF AND COMMAND

Fire – The water tender has had the pump added and Witek wanted to give D Jordan congratulations for a job well done.

- #351, the new pickup has the skid unit installed but still needs emergency lighting, so it is not in service yet
- Our COVID protocol is based on IDPH guidelines and the same as BK and
 Oswego FPD. All members either must be vaccinated or are subject to weekly testing.
- An accident in the district with a 10-year-old pinned in the vehicle needing extraction has brought to light the imminent need for paid fire crews. When this call came in Chief Witek recognized the immediate need for mutual aid, so he had a neighboring department dispatched and the other department performed the extraction. Witek is making budget adjustments to allow for hiring 12-20 individuals to create a pool that allows 3 people to man a 24-7 engine and work in conjunction with the 4 paramedics that are on duty. These individuals will not have any benefits.
